THE HARINGEY (MAYES ROAD, PARKLAND ROAD, TOWER TERRACE N22) (TEMPORARY PROHIBITION AND RESTRICTION OF TRAFFIC) ORDER 2022



The 'Council' of the London Borough of Haringey being the traffic authority for certain roads in that London borough is satisfied that traffic should be prohibited because works are being or are proposed to be executed on or near those roads and in exercise of its powers under Section 14(1) of the Road Traffic Regulation Act 1984, as amended and of all other enabling powers the Council hereby makes the following Order.

1. This Order shall come into force on \*\*\*\*\* and may be cited as the Haringey (\*\*\*\*\* (Temporary Prohibition and Restriction of Traffic) Order 20\*\*.
2. Whilst the Order is in force, no person shall cause or permit any vehicle to: -
  - (a) enter or proceed in the lengths of roads specified in column 2 of Schedule 1 to this Order during the dates and times specified in column 1 of that Schedule; and
  - (b) wait, load or unload in the lengths of roads specified in column 2 of Schedule 2 to this Order during the dates and times specified in column 1 of that Schedule other than those vehicles exempted from such restrictions specified in column 2 to that Schedule;
3. Whilst this Order is in force, any parking place, loading bay, bus stop, bus stand, bus lane, cycle lane or pedestrian crossing located in a length of road specified in column 2 of Schedule 2 to this Order shall be suspended during the dates and times specified in column 1 of that Schedule.
4. 'The Haringey (Free Parking Places, Loading Places and Waiting, Loading and Stopping Restrictions) Order 2021' and 'The Haringey (Charged-For Parking Places) Order 2021' are hereby temporarily amended as detailed in Article 2(b) and 3 to this Order.
5. The prohibitions and restrictions specified in articles 2 and 3 above shall apply only during such times and to such extent as shall be indicated by traffic signs as prescribed by The Traffic Signs Regulations and General Directions 2016.
6. Nothing in **Article 2 (a), (b), (d) (e)** to this Order shall apply to: -
  - (a) any vehicle being used in connection with the works;
  - (b) any vehicle being used for fire brigade, police or ambulance purposes;
  - (c) any vehicle exempted from the restrictions as defined in column 2 of Schedule 2 to this Order;
  - (d) anything done with the permission or at the direction of a police constable in uniform, a traffic warden or a civil enforcement officer;
  - (e) any vehicle requiring ingress to, and egress from, a property in a prohibited length of road, if the works allow.
7. **Nothing in Article 2(c) to this Order shall apply to such vehicles during the permitted hours specified in column 1 of Schedule 3 which display in the relevant position a disabled persons' badge.**
8. The Order may continue in force for up to 18 months unless extended by the Secretary of State.

Access to car park for residents to be maintained.</p> <p><b>Mayes Road</b> Closure of Mayes Road from the roundabout junction of Station Road and Mayes Road to the roundabout junction of Mayes Road and Western Road.</p>

<p>Date: Fri 16<sup>th</sup> Dec 2022 to Thurs 1<sup>st</sup> June 2023 Time: 24hrs</p>	<p><b>Tower Terrace</b> Part 1) Suspension of CPZ resident permit parking on south east side of Tower Terrace from outside No.13 to No.17 (inclusive).</p> <p><b>Tower Terrace</b> Part 2) Suspension of CPZ resident permit parking on south east side of Tower Terrace from outside No.9 to No.13 Tower Terrace (inclusive).</p> <p><b>Parkland Road</b> Part 2) Suspension of shared use CPZ resident permit parking/pay to park bays on the south west side of Parkland Road, from behind the disabled bay outside No.9 Parkland Road to No. 63 Parkland Road.</p>
