The Haringey (Charged-For Parking Places) (Amendment No.12) Order 2023

Made: 30th June 2023

Coming into force: 21st August 2023

The London Borough of Haringey, after consulting the Commissioner of Police of the Metropolis, in exercise of the powers conferred by sections 45, 46, 49, 51 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984(**a**) as amended by the Local Government Act 1985 and the Traffic Management Act 2014 and of all other powers thereunto enabling, hereby make the following Order:

Citation and commencement

1. This Order may be cited as the Haringey (Charged-For Parking Places) (Amendment No.12) Order 2023 and shall come into force on 21st August 2023.

Interpretation

- 2. (1) In this Order: "the Order of 2021" means The Haringey (Charged-For Parking Places) Order 2021(**b**).
 - (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
 - (3) Unless the context otherwise requires, any expression used in this Order which is also used in the Order of 2021 shall have the same meaning as in that Order.

Amendment to the Order of 2021

- 3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the Order of 2021 shall have effect as though:
 - (a) the expression 'carer' in Article 3(1) to that Order be substituted with the following expression set out below:

"carer", for the purposes of this Order, means a person who is either:-

- (a) in receipt of a Department for Work and Pensions Carers Allowance and who is registered as a carer with the Council; or
- (b) has satisfied such criteria as may be set from time to time by the Council to support an application for a Care at Home parking permit issued under the provisions of this Order;

and who is providing care to a resident living at an address in a controlled parking zone within the London Borough of Haringey;

(b) the expression 'permit' in Article 3(1) to that Order be substituted with the following expression set out below:

"permit" means either a residents permit granted or issued under the provisions of Article 24(3), or a business permit granted or issued under the provisions of Article 25(3), or a visitor permit granted or issued under the provisions of Article 26(3), or an essential service permit granted or issued under the provisions of Article 27(3), or a care at home parking permit granted or issued under the provisions of Article 28(3), or a traders permit

granted or issued under the provisions of Article 29(3), or a borough-wide or utilities permit granted or issued under the provisions of Article 30(3); or a street traders permit granted or issued under the provisions of Article 31(3), or a doctors permit granted or issued under the provisions of Article 32(3), or a car club permit granted or issued under the provisions of Article 33(3), or a disabled permit granted or issued under the provisions of Article 34(3); or a special permit granted or issued under the provisions of Article 35(3);

- (c) the expression 'carers permit' to be replaced with 'care at home parking permit' in Article 5 (2) to (5).
- (d) the expression 'carers permit' to be replaced with 'care at home parking permit' in Article 6 (1) to (4).
- (e) for Article 28(1) to (3) to that Order there was substituted with the Article similarly numbered and set out below:-

Application for and grant or issue of carer at home parking permits

- 28. (1) Any resident who lives within a Controlled Parking Zone (CPZ) may apply to the Council or authorised agent for the grant or issue of a Care at Home parking permit to facilitate essential home visits by a doctor, district nurse, similar healthcare professional or voluntary care in respect of that resident and any such application shall be made by way of an online form accessible by way of the Council's website, or on a form issued by and obtainable from the Council or authorised agent and shall include the particulars and information required by such form to be supplied.
 - (2) The Carer at Home parking permit will be restricted to the CPZ to which the resident resides and will be issued in paper form, allowing it to be transferred between vehicles for use solely by carers of that particular resident.
- (3) The Council or authorised agent may at any time require an applicant for a Care at Home parking permit to produce to an officer of the Council or authorised agent such evidence in respect of an application for a Care at Home parking permit made to them as they may reasonably call for to verify any particulars or information given to them in respect of any such permit granted or issued by them as they may reasonably call for to verify that the permit is valid.
- (4) Upon receipt of an application duly made under the foregoing provisions of this Article, the Council or authorised agent upon being satisfied that the resident is receiving care via essential home visits shall grant or issue to the resident one Care at Home parking permit to allow a carer to leave their vehicle in any parking place to which such permit relates and without a time limit for the purpose of providing care to the resident.
- (5) any residents requiring more than one carer at a time will be entitled to access paper visitor parking permits at the concessionary charge.
- (6) The Care at Home parking permit will be valid for up to 3 years from the date the permit first became valid. The resident will need to reapply for the applicable permit before it expires. If the home care is time limited, the permit will be valid for as long as is required.
- (f) for Article 42 to that Order there was substituted the Article similarly numbered and set out below:-

Surrender, withdrawal and validity of permits other than visitor permits

- 42. (1) A permit holder may surrender a permit to the Council or authorised agent at any time and shall surrender such permit to the Council or authorised agent on the occurrence of any one of the events set out in paragraph (3) of this Article.
 - (2) The Council or authorised agent may, by notice in writing served on the permit holder, by sending the same by the recorded delivery service to that permit holder at the address shown by that person or business or organisation on the application for that permit or at any other address believed to be that person's place of abode, or place of business, or premises, withdraw a permit if any one of the events set out in paragraph (3)(a), (b), (c), (d), (e), (f), (g), (h), (i), (j), (k) or (l) of this Article has occurred and the permit holder shall surrender that permit to the Council or authorised agent within 48 hours of the receipt of the aforementioned notice.
 - (3) The events referred to in the foregoing provisions of this Article are:
 - (a) in relation to a residents permit holder, the permit holder ceasing to be a resident;
 - (b) in relation to a business permit holder, the business permit holder ceasing to be a business user;

- (c) in relation to an essential service permit holder, the essential service permit holder ceasing to be an essential service provider; or
- (d) in relation to a Care at Home parking permit holder, the permit holder ceases to be a resident or no longer requires care at home;
- (e) in relation to a borough-wide or utilities permit holder, the borough-wide or utilities permit holder ceasing to be a borough-wide or utilities user
- (f) in relation to a street traders permit holder, the street traders permit holder ceasing to be a street trader;
- in relation to a doctors permit holder, the doctors permit holder ceasing to be a doctor or ceasing to practice at the location in respect of which the doctors permit was granted or issued;
- (h) in relation to a car club permit: the car club to which the car club permit has been granted or issued ceasing to be a car club authorised by the Council, or the car club ceasing to be the user of the parking place in respect of which the car club permit was granted or issued, or the parking place in respect of which the car club permit has been granted or issued is revoked or suspended and no alternative car club bay has been provided by the Council;
- (i) in relation to a disabled permit, the disabled permit holder ceasing to be a resident or to fulfil the criteria set out in Article 34(1);
- (j) in relation to a special permit, the special permit holder ceasing to meet the criteria of the issue of the permit;
- (k) in relation to a permission to park permit, the permission to park permit holder ceasing to meet the criteria of the issue of the permit;(m) the permit holder ceasing to be the keeper of the vehicle in respect of which that permit was issued;
- (I) in relation to a disabled virtual residential parking permit, the disabled virtual residential parking permit holder ceasing to meet the criteria set out in Article 38(1) or the permit holder ceasing to be the keeper of the vehicle in respect of which that permit was issued:
- (m) the vehicle in respect of which such permit was issued being adapted or used in such a manner that it is not a vehicle of the class specified in Article 31(1) in the case of a street traders permit, or a vehicle of the class specified in Article 5(1) in the case of any other permit;
- (n) the issue of a duplicate permit by the Council or authorised agent under the provisions of Article 40;
- (o) the permit ceasing to be valid pursuant to the provisions of paragraph (4) of this Article;
- (p) the visitor permit being transferred by the permit holder to another person for that person's use.

Without prejudice to the foregoing provisions of this Article, a permit shall cease to be valid at the expiration of the period specified thereon or on the occurrence of any one of the events set out in sub-paragraph (3)(a), (b), (c), (d), (e), (f), (g), (h), (i), (j), (k), (l), (m), (n), (o) or (p) of this Article, whichever is the earlier.

(g) the item numbered 6 in Schedule 3 of that Order shall be substituted with the details set out below:-

Care at Home parking permit

6. The Care at Home parking permit referred to in Article 28(4) shall be free of charge.

EXPLANATORY NOTE

(This is not part of the Order but used to help explain its purpose) The Haringey (Charged-For Parking Places) (Amendment No.12) Order 2023

The general effect of the Order, is to replace the existing Resident Carer Permit with the Care at Home parking permit that offers one free transferable permit to residents living within a Controlled Parking Zone (CPZ), who require essential home visits by a doctor, district nurse, similar healthcare professional or voluntary carers.

The new Care at Home Permit:

- a) will be limited to the CPZ in which the applicant resides
- b) may be used only in permit holder/resident permit holder and shared use (permit holder/resident permit holder or pay by phone) parking bays.
- c) will be in paper form, allowing it to be transferred between vehicles for use solely by carers
- d) may be used without time limit, whilst care is being provided
- e) will be limited to one free Care at Home permit per applicant which will be valid for 3 years.
- f) any residents requiring more than one carer at a time will be entitled to access paper visitor parking permits at the concessionary charge.
- g) will be free of charge and transferrable.

Notice is hereby given that the Council of the London Borough of Haringey on 30th June 2023 has made the above mentioned Orders under sections 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.

The general effect of the Order: To replace the existing Resident Carer Permit with the Care at Home parking permit that offers one free transferable permit to residents living within a Controlled Parking Zone (CPZ), who require essential home visits by a doctor, district nurse, similar healthcare professional or voluntary carers.

The new Care at Home Permit:

- a) will be limited to the CPZ in which the applicant resides
- b) may be used only in permit holder/resident permit holder and shared use (permit holder/resident permit holder or pay by phone) parking bays.
- c) will be in paper form, allowing it to be transferred between vehicles for use solely by carers
- d) may be used without time limit, whilst care is being provided
- e) will be limited to one free Care at Home permit per applicant which will be valid for 3 years.
- f) any residents requiring more than one carer at a time will be entitled to access paper visitor parking permits at the concessionary charge.
- g) will be free of charge and transferrable.

Date of operation: The Orders will come into operation on 21st August 2023.

Application to the high court: Any person desiring to question the validity of the Orders or of any provision contained therein on the grounds that it does not comply with the relevant powers of the Road Traffic Regulation Act 1984, as amended or that any of the relevant requirements thereof or of any relevant regulations made there under have not been complied with in relation to the Orders may, within six weeks of the date on which the Orders were made, make application for the purpose to the High Court.
