THE HARINGEY (COLINA MEWS N15) (TEMPORARY PROHIBITION AND RESTRICTION OF TRAFFIC) (NO.2) ORDER 2022

ROAD TRAFFIC REGULATION ACT 1984 – SECTION 14(1)

The Council of the London Borough of Haringey has made the Temporary Traffic Order described below:-

Street Name – Colina Mews N15	
Reason for 14(1) Order – <ul style="list-style-type: none">To accommodate changes to parking bays approved by the LBOH planning service under S278 agreement/s.To improve Road and Safety in Colina Mews as a part of the new housing development works taking place on this road. To control the waiting and loading activity on this narrow road whilst the works are taking place on this road.To facilitate safe passing of two-way traffic on this road past the approved parking bay changes on this road.

Date: Thurs 23rd February 2023 to Wed 23rd August 2023 Time: 24hr	<ol style="list-style-type: none">To introduce double yellow lines on east side of Colina Mews N15 outside the shared property boundary of No.37a/37b to outside the shared property boundary of No.73/75.To introduce Permit Parking bays on east side of Colina Mews N15 from outside the shared property boundary of No.73/75 to outside No.55 (3.15 metres north of the shared boundary of No.53/55).To introduce double yellow lines on east side of Colina Mews N15 outside No.55 (3.15 metres north of the shared boundary of No.53/55) to join the existing double yellow lines at the junction with Colina Road N15.To replace the single yellow line & Business Permit bays with double yellow line on west side of Colina Mews N15 from existing double yellow lines at its junction with Colina Road to outside flats 1-9 at No.1 Colina Mews.To reduce the existing resident permit parking bays on west side of Colina Mews N15 outside flats 1-9 at No.1 Colina Mews by 7.6 metres and replace with double yellow lines.

The provisions of the Orders shall apply only at such times and as directed by traffic signs. For road closures, alternative routes will be directed by traffic signs. THE HARINGEY (COLINA MEWS N15) (TEMPORARY RESTRICTION OF TRAFFIC) (NO.2) ORDER 2022



Coming into force: 23rd February 2023

The 'Council' of the London Borough of Haringey being the traffic authority for certain roads in that London borough is satisfied that traffic should be prohibited because works are being or are proposed to be executed on or near those roads and in exercise of its powers under Section 14(1) of the Road Traffic Regulation Act 1984, as amended and of all other enabling powers the Council hereby makes the following Order.

1. This Order shall come into force on 23rd February 2023 and may be cited as the Haringey (Colina Mews N15) (Temporary Restriction of Traffic) (No.2) Order 2023
2. Whilst the Order is in force, no person shall cause or permit any vehicle to: -
 - (a) wait, in the lengths of roads specified in column 2 of Schedule 2 to this Order during the dates and times specified in column 1 of that Schedule other than those vehicles exempted from such restrictions specified in column 2 to that Schedule;
 - (b) wait or load in the lengths of roads specified in column 2 of Schedule 3 to this Order during the dates and times specified in column 1 of that Schedule other than those vehicles exempted from such restrictions specified in Article 8. These areas are to be bounded on one side of that length by the edge of the carriageway and having a width throughout of 1.83 metres and are temporarily designated as a parking place.
3. Whilst this Order is in force, any parking place or waiting restrictions located in a length of road specified in column 2 of the Schedules to this Order shall be suspended during the dates and times specified in column 1 of the Schedules.
4. 'The Haringey (Free Parking Places, Loading Places and Waiting, Loading and Stopping Restrictions) Order 2021' and 'The Haringey (Charged-For Parking Places) Order 2021' are hereby temporarily amended to include the restrictions detailed in Article 2 and suspend the restrictions as detailed in Article 3 to this Order.
5. The restrictions specified in articles 2 and 3 above shall apply only during such times and to such extent as shall be indicated by traffic signs as prescribed by The Traffic Signs Regulations and General Directions 2016.
6. The provisions of 'The Haringey (Free Parking Places, Loading Places and Waiting, Loading and Stopping Restrictions) Order 2021' shall apply to the waiting restrictions introduced by this Order as if in those provisions any reference to the waiting restrictions included a reference to the waiting restrictions by this Order.
7. The provisions of 'The Haringey (Charged-For Parking Places) Order 2021' shall apply to each area designated as a parking place by this Order as if in those provisions any reference to a parking place included a reference to each area designated as a parking place by this Order.
8. Nothing in Article 2(b) to this Order shall apply to such vehicles during the permitted hours specified in column 1 of Schedule 3 which display in the relevant position a Wood Green Outer permit or Wood Green Outer visitor permit.
9. The Order may continue in force for up to 18 months unless extended by the Secretary of State.

Schedule 1 – Introduction of No Waiting at Any Time

Dates and Times	Lengths of Roads
Date: Thurs 23rd February 2023 to Wed 23rd August 2023 Time: 24hr	Colina Mews N15 east side outside the shared property boundary of No.37a/37b to outside the shared property boundary of No.73/75, a distance of 58.6 metres. Colina Mews N15 east side from a point 3.15 metres north of the shared boundary of No.53/55 to the existing double yellow lines at the junction with Colina Road N15, a distance of 11.3 metres. Colina Mews N15 west side from existing double yellow lines at its junction with Colina Road to outside flats 1-9 at No.1 Colina Mews, a distance of 94.4 metres.

Schedule 2 – Permit Holders Only Parking Place

Dates and Times	Lengths of Roads
Date: Thurs 23rd February 2023 to Wed 23rd August 2023 Time: 24hr	Colina Mews N15 - from outside the shared property boundary of No.73/75 to a point 3.15 metres north of the shared boundary of No.53/55, a distance of 51 metres.
