- 1. The Council of the London Borough of Haringey, in consultation with Transport for London, hereby gives notice that to allow for a special event it has made the above Order under Section 16(a) of the Road Traffic Regulation Act 1984.
- The general effect of the Order would be to prohibit any vehicle from entering or proceeding in Scotland Green Road N17 between 8am and 11pm on Saturday 16th December 2023. This prohibition would operate between the junction with High Road, eastwards to the existing bollards next to No.54.
- 3. The prohibition specified in Article 2 above, shall only apply during such times and to such extent as may be indicated by appropriate traffic signs or directed by a police constable in uniform or a civil enforcement officer.

SECTION 16A – ROAD TRAFFIC REGULATION ACT 1984

THE HARINGEY (SCOTLAND GREEN ROAD N17) (TOTTENHAM WINTER FESTIVAL) TEMPORARY PROHIBITION OF TRAFFIC ORDER 2023

Made: 30th November 2023

Coming into operation: 16th December 2023

The 'Council' of the London Borough of Haringey being the traffic authority for certain roads in that London borough is satisfied that traffic should be prohibited by reason of a special event and in exercise of its powers under Section 16A of the Road Traffic Regulation Act 1984, as amended and of all other enabling powers the Council hereby makes the following Order.

- 1. This Order shall come into operation on 16th December 2023 and may be cited as the Haringey (Scotland Green Road N17) (Tottenham Christmas Fair) Temporary Prohibition of Traffic Order 2023.
- 2. Whilst the Order is in force, no person shall cause or permit any vehicle to enter or proceed in the lengths of roads specified in column 2 of the Schedule to this Order during the dates and times specified in column 1 of that Schedule;
- **3.** The prohibitions and restrictions specified in article 2 above shall apply only during such times and to such extent as shall be indicated by traffic signs as prescribed by The Traffic Signs Regulations and General Directions 2016.
- 4. Nothing in this Order shall apply to: -
 - (a) any vehicle being used in connection with the event;
 - (b) any vehicle being used for fire brigade, police or ambulance purposes;
 - (c) anything done with the permission or at the direction of a police constable in uniform or a traffic warden;
 - (d) any vehicle necessitating access to a property in a prohibited length of road, if the event allows.
