## THE HARINGEY (VARIOUS ROADS, SOUTH TOTTENHAM CPZ, PURIM FESTIVAL) (SPECIAL EVENTS) ORDER 2024

Made: 14th March 2024

Coming into force: 24th March 2024

The 'Council' of the London Borough of Haringey being the traffic authority for certain roads in that London borough is satisfied that traffic should be prohibited while the Purim Religious Festival takes on or near those roads and in exercise of its powers under Section 16(A) of the Road Traffic Regulation Act 1984, as amended and of all other enabling powers the Council hereby makes the following Order.

- 1. This Order shall come into force on 24<sup>th</sup> March 2024 and may be cited as the Haringey (Various Roads, South Tottenham CPZ, Purim Festival) (Special Events) Order 2024.
- 2. Whilst the Order is in force, no person shall cause or permit any vehicle to proceed in the lengths of roads specified in column 1 of the Schedule to this Order in a direction other than specified in column 2 of that Schedule during the dates and times specified in the Schedule;
- **3.** The prohibitions and restrictions specified in articles 2 and 3 above shall apply only during such times and to such extent as shall be indicated by traffic signs as prescribed by The Traffic Signs Regulations and General Directions 2016.
- 4. Nothing in Article 2 to this Order shall apply to: -
  - (a) any vehicle being used for fire brigade, police or ambulance purposes;
  - (b) anything done with the permission or at the direction of a police constable in uniform, a traffic warden or a civil enforcement officer;
- 5. The Order may continue in force for up to 3 days unless extended by the Secretary of State.
