## Outcome of Statutory Consultation and Works Notice

### Installation of Electric Vehicle Charging Points (EVCP's) - 2023/24 Batch 1

Dear Resident or Business,

You may recall that we consulted you in November/December 2023 regarding the possible introduction of 40 Electric Vehicles Charging Points (EVCP's)/bays at 19 locations in the borough. We received a good response to the consultation and on behalf of the Council, we would like to thank all those who took the time to have their say and make their views known.

As part of the decision-making process, the council have given careful consideration to all comments and objections received, with the proposed introduction of 36 EVCPs having now been approved. The council will now proceed with the introduction of EVCPs at the locations provided with this letter. These EVCP's will be part of the Source London network and accessible to Source London members and all other users on 'pay as you go' bases.
