# THE HARINGEY (VARIOUS ROADS – ALEXANDRA PALACE FIREWORK DISPLAY) (TEMPORARY PROHIBITION AND RESTRICTION OF TRAFFIC) ORDER 2024

The Council of the London Borough of Haringey has made the above Temporary Traffic Order under S14(1) Road Traffic Regulation Act 1984 for public safety and to facilitate the Alexandra Palace Firework display;

#### THE GENERAL EFFECT OF THE ORDER:

# THE HARINGEY (VARIOUS ROADS – ALEXANDRA PALACE FIREWORK DISPLAY) (TEMPORARY PROHIBITION AND RESTRICTION OF TRAFFIC) ORDER 2024

Made: 30th October 2024

Coming into force: 31st October 2024

The 'Council' of the London Borough of Haringey being the traffic authority for certain roads in that London borough is satisfied that traffic should be prohibited because works are being or are proposed to be executed on or near those roads and in exercise of its powers under Section 14(1) of the Road Traffic Regulation Act 1984, as amended and of all other enabling powers the Council hereby makes the following Order.

- **1.** This Order shall come into force on 31<sup>st</sup> October 2024 and may be cited as the Haringey (Various Roads Alexandra Palace Firework Display) (Temporary Prohibition and Restriction of Traffic) Order 2024.
- 2. In this Order:

'Permit holder' means any person issued with a permit from Alexandra Palace.

- 3. Whilst the Order is in force, no person shall cause or permit any vehicle to: -
  - (a) enter or proceed in the lengths of roads specified in column 2 of Schedule 1 to this Order during the dates and times specified in column 1 of that Schedule other than those vehicles exempted from such restrictions specified in column 3 to that Schedule; and
  - (b) wait, load or unload in the lengths of roads specified in column 2 of Schedule 2 to this Order during the dates and times specified in column 1 of that Schedule;
- **4.** Whilst this Order is in force, any parking place, loading bay, bus stop, bus stand, bus lane, cycle lane or pedestrian crossing located in a length of road specified in column 2 of Schedule 2 to this Order shall be suspended during the dates and times specified in column 1 of that Schedule.
- 5. 'The Haringey (Free Parking Places, Loading Places and Waiting, Loading and Stopping Restrictions) Order 2021' and 'The Haringey (Charged-For Parking Places) Order 2021' are hereby temporarily amended as detailed in Article 3(b) and 4 to this Order.
- 6. The prohibitions and restrictions specified in article 3 above shall apply only during such times and to such extent as shall be indicated by traffic signs as prescribed by The Traffic Signs Regulations and General Directions 2016.
- 7. Nothing in Article 3 to this Order shall apply to: -
  - (a) any vehicle being used in connection with the Alexandra Palace fireworks display;
  - (b) any vehicle being used for fire brigade, police or ambulance purposes;
  - (c) any vehicle exempted from the restrictions as defined in column 3 of Schedule 1 to this Order;
  - (d) anything done with the permission or at the direction of a police constable in uniform, a traffic warden or a civil enforcement officer:
- 8. The Order may continue in force for up to 18 months unless extended by the Secretary of State.
